1. Name, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993, the Regional Committee hereby gives recognition to National Swarnajayanti Scheme Degree College, 3, Atarvada Road, PO - Kalyand, Dist. Alwarabad, Uttar Pradesh - 211009 for a total intake of 100 seats (One Hundred seats) in B.Ed. course of One year duration with effect from the academic session 2024-2025 subject to fulfilment of the following before the commencement of the session:

- a. Appointment of the faculty members duly qualified and staff on per the norms of NCTE/State Govt./UGC to be completed before the commencement of the session.
b. The counter signed statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2024-2025.
c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
d. The institution shall within one month of the receipt of Recognition order, convert the Government Fund received into a Joint Account in the form of FD in favour of not less than 90 months (90 months) in a bank notified bank only to the accountancy wing of the office of the Regional Committee.
e. That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and deposited in the form of FD in favour of the management/institution for a period of not less than six months (Six months) in a nationalized bank.
f. Non-compliance of the above mentioned condition shall constitute violation of section 17 (1) of NCTE Act 1993.
3. The Recognition is subject to the condition that the affording University shall ensure that within a three months the institution has recruited required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / University.

The institution shall submit to the Regional Committee a self-Assessment Report at the end of each academic year along with a copy of the approval of the affording University / State Directorate of Education about the appointment of faculty members and the statement of Annual Accounts duly audited by a Chartered Accountant.
6. In the institution compliance copy of the above conditions or any of the provisions of the Act shall be submitted to the Registrar under the provision of Section 17(D) of the NCTE Act, 1993.
